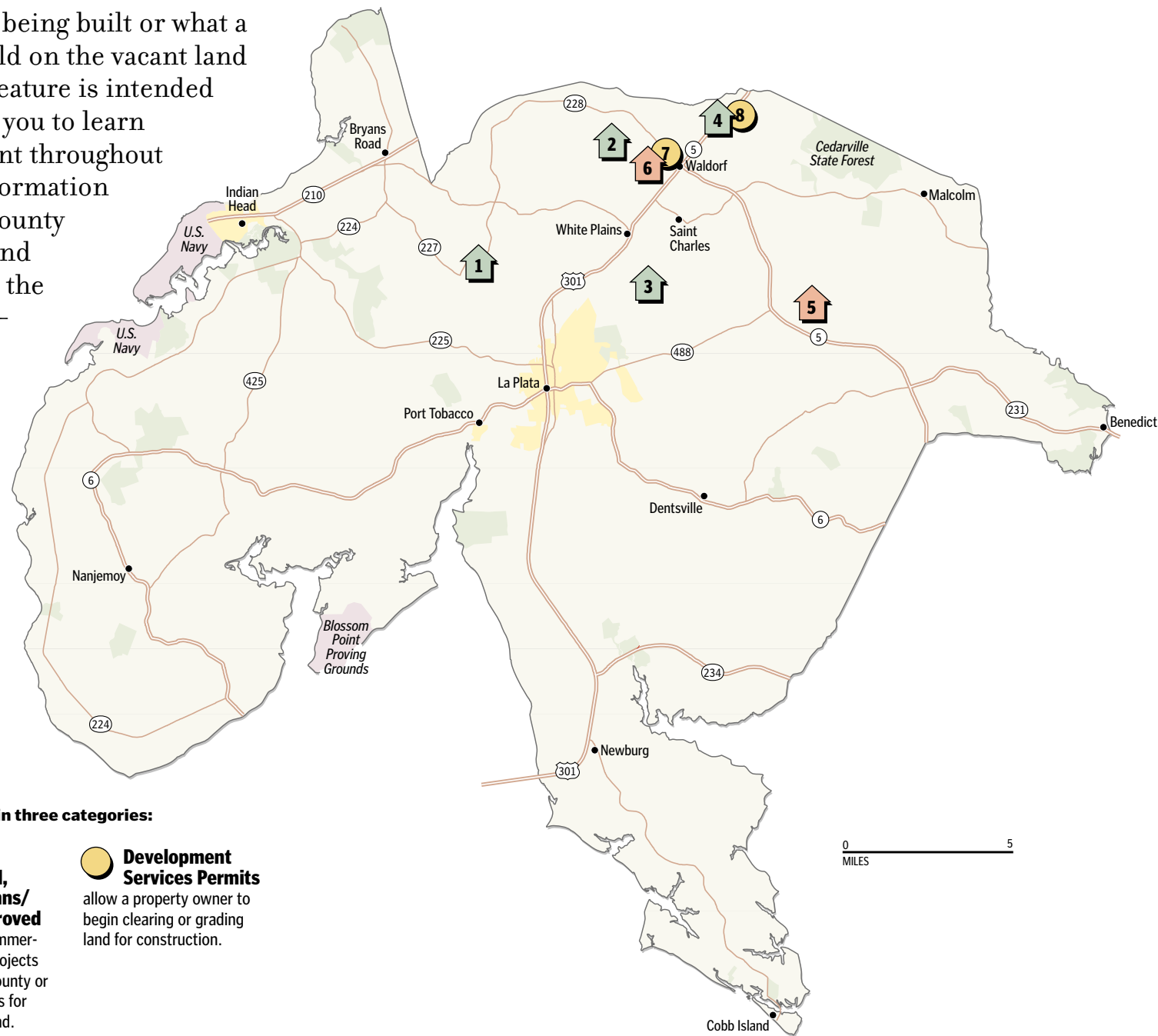


What's Going Where in Charles County

Ever wonder about what's being built or what a developer proposes to build on the vacant land around the corner? This feature is intended to provide an easy way for you to learn about planned development throughout Charles County. Using information provided by the Charles County Department of Planning and Growth Management, and the town of La Plata zoning office, the Southern Maryland Extra gives you a monthly update on planned subdivisions, office buildings, shopping centers and other development. The map and chart identify by districts planned projects that were recently processed.



The status of the projects is described in three categories:

Projects Proposed, Preliminary Plans/Site Plans Proposed
are residential, commercial or industrial projects submitted for approval.

Projects Approved, Preliminary Plans/Site Plans Approved
are residential, commercial or industrial projects approved by the county or incorporated towns for development of land.

Development Services Permits
allow a property owner to begin clearing or grading land for construction.

Waldorf Area
2. First Baptist Church, 10045 Bunkerhill Rd. Site plan for an addition to a church sanctuary. SDP 070021.

3. Glen Eagles Apartments, off Billingsley

Road, near Piney Church Road. Site plan for multi-family garden apartments. SDP 070027.

4. R.L. Litten & Associates, 2725 Old Washington Rd. Site plan for a church. SDP 070025.

5. Mill Spring Estates, Huckleberry Drive. Preliminary plan to subdivide 79.96 acres for a 25-lot subdivision. XPN 06-0021.

6. St. Charles Mini-Storage, St. Nicholas Drive. Site plan for a storage facility. SDP 060045.

7. Courtyard Marriott, south of Best Buy store, along Waldorf Marketplace access drive. Plan for a hotel on 3.8 acres. VC 40114.

8. Marquee Autowash, north of Route 925 and Acton Lane. Plan for a car wash. VC 60089.
