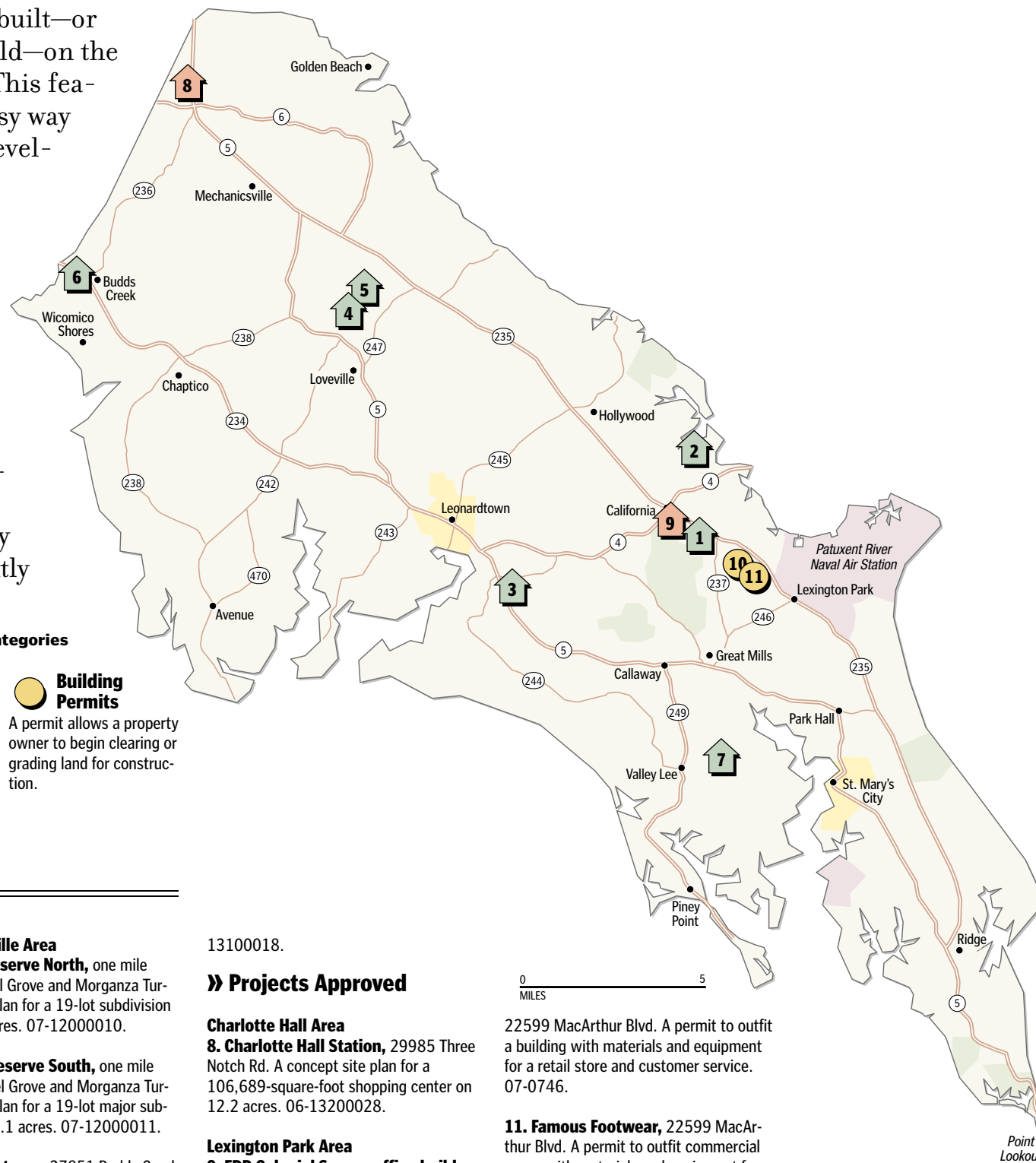


What's Going Where in St. Mary's County

Ever wonder about what's being built—or what a developer proposes to build—on the vacant land around the corner? This feature is intended to provide an easy way for you to learn about planned development throughout St. Mary's County. Using information collected by the St. Mary's County Department of Land Use and Growth Management and the Leonardtown Planning and Zoning Commission, the Southern Maryland Extra provides a monthly update on planned subdivisions, office buildings, shopping centers and other development. The map and chart identify planned projects that were recently processed by officials.

The status of the projects is described in three categories

-  **Projects Proposed**
Preliminary plans, site plans and concept plans are residential, commercial or industrial projects submitted for approval. Public hearings are held before any action by the Planning Commission.
-  **Projects Approved**
Preliminary plans and site plans are residential, commercial or industrial projects approved by the Planning Commission.
-  **Building Permits**
A permit allows a property owner to begin clearing or grading land for construction.

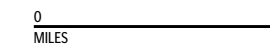
