Narrative

On January 18, 2007 at approximately 1649 hours I was dispatched to a 911 call at the [REDACTED] regarding a suspicious person. Dispatch also advised the suspicious person was seen masterbating on the beach and by the pool area of the hotel. I was also advised the suspicious person had left the area of the [REDACTED] in a black convertible Saab. When I arrived at the [REDACTED], I drove to the back part of the hotel towards the Tiki Bar and Pool. In this area I observed several people pointing to a black convertible Saab and saying "that is the guy." I stopped the vehicle and spoke with the person seated in the drivers seat. I asked the driver for a drivers license and he gave me a government identification card. The individual was identified as Joseph M. McDade. I told Mr. McDade the reason I was stopping him and said he understood. I asked Mr. McDade for his drivers license and he stated he did not have it with him, saying it must be in his other wallet. I asked Mr. McDade for his date of birth, which he stated was 09/29/31. I gave Sanibel dispatch this information to verify Mr. McDade's drivers license was valid. I told Mr. McDade to give me a minute, so I could speak with the complainant/victim.

I spoke with [REDACTED]. [REDACTED] stated she was standing outside her friend's hotel room talking to her son on her cell phone when she observed Mr. McDade standing near the pool area masterbating. [REDACTED] stated she observed Mr. McDade moving his hand in a back and forth motion while grasping his penis. [REDACTED] hung the phone up and called 911. She continued stating Mr. McDade was approximately 10-15 feet from her when she was observing him masterbating.

While speaking with [REDACTED], [REDACTED] approached me and told me the same individual followed his wife from the beach and watched her and played with his penis. [REDACTED] stated he watched Mr. McDade following his wife from the beach and observed Mr. McDade play with his penis.

I spoke with [REDACTED] who stated she was on the beach and when she got up from her lawn chair she observed Mr. McDade watching her. She stated she tried not to make eye contact with him, but, looked up again and saw Mr. McDade still watching her playing with his penis. [REDACTED] stated she put her beach cover up on and walked from the beach to the boardwalk leading to the hotel, and Mr. McDade followed her. [REDACTED] stated she went to wash her feet at the foot shower and saw Mr. McDade playing with his penis. She stated the penis was never hard, but, he was still rubbing it and playing with his penis on the beach boardwalk. [REDACTED] continued stating she thought Mr. McDade was a mental patient because he did not try to hide himself while he was masterbating and he was masterbating in front of everyone at the resort. I asked [REDACTED] if she saw any children on the beach and she stated there were several children on the beach, but, is unsure if they saw him. [REDACTED] also stated she saw children throughout the resort.

I spoke with guest relations regarding Mr. McDade. I asked management if Mr. McDade was a registered guest at the hotel and guest relations stated he was not. Management did advise Mr. McDade was a guest on January
