

# Named in the Probe

The following is a list of the 91 players cited in the Mitchell report and a brief summary of the reason for his inclusion.

The report includes everything from anonymous published reports to first-hand descriptions of drug use.

Unless noted, the players listed below declined to speak with the commission's investigators.

**MANNY ALEXANDER**  
IF, not in majors



MLB official Rob Manfred testified that police found steroids and syringes in Alexander's car, which he'd loaned to a clubhouse attendant. Charges against the player were dismissed.

**CHAD ALLEN**  
OF, not in majors



Purchased Winstrol from Radomski during the 2003 offseason.

**MIKE BELL**  
3B, St. Louis



Purchased a shipment of HGH from Radomski while in the minor leagues during the 2003 offseason.

**GARY BENNETT JR.**  
C, St. Louis



Bought two kits of HGH in July 2003, according to Radomski.

**LARRY BIGBIE**  
OF, L.A. Dodgers



Bought a variety of performance-enhancing substances, including Deca-Durabolin, Sustanon and HGH, according to Radomski.

**RICKY BONES**  
P, Florida



In 2000, an attendant discovered a bag that had two dozen syringes, Winstrol and Deca-Durabolin in Bones's locker. Bones said he took the drugs for a degenerative hip condition.

**KEVIN BROWN**  
P, not in majors



Radomski said Brown asked for HGH after suffering an injury in 2000. Brown paid in cash via express mail for HGH, and once for Deca-Durabolin, over the next two or three years.

**KEN CAMINITI**  
3B, deceased



Admitted in a Sports Illustrated story in 2002 that he used anabolic steroids in 1996 and estimated that "at least half" of MLB players were using them as well.

**MARK CARREON**  
1B-OF, not in majors



Radomski said he provided Carreon with Dianabol pills toward the end of his tenure with the Giants, which lasted from 1994 through the middle of the 1996 season.

**JASON CHRISTIANSEN**  
P, not in majors



Radomski said Christiansen made a one-time purchase of HGH in 2002.

**HOWIE CLARK**  
3B-OF, Minnesota



Radomski said he made four or five sales of HGH to Clark.

**ROGER CLEMENS**  
P, free agent



Brian McNamee said he injected Clemens with Winstrol during 1998, with HGH and Sustanon 250 or Deca-Durabolin during 2000, and again with Sustanon 250 or Deca-Durabolin in 2001.

**PAXTON CRAWFORD**  
P, not in majors



Admitted in two print accounts to taking HGH and anabolic steroids.

**JACK CUST**  
OF-DH, Oakland



Former teammate Larry Bigbie said Cust told him he had tried steroids and had a source who could procure anything Bigbie wanted.

**BRENDAN DONNELLY**  
P, free agent



Radomski said Donnelly called him in 2004 looking for Anavar, an anabolic steroid. Radomski made one sale to Donnelly of Deca-Durabolin.

**CHRIS DONNELLS**  
3B, not in majors



Radomski sold HGH and steroids to Donnels, who agreed to speak with investigators. Radomski sold him testosterone, Dianabol, Deca-Durabolin, human growth hormone and other substances.

**LENNY DYKSTRA**  
CF, not in majors



According to Radomski, Dykstra admitted that he took steroids during in 1989. Radomski recalled providing Dykstra with Deca-Durabolin, Dianabol, and testosterone.

**MATT FRANCO**  
1B, not in majors



Radomski said he sold Franco steroids once in 2000 after Franco called him. Franco denied ever using any performance-enhancing substance or meeting, knowing or talking with Radomski.

**RYAN FRANKLIN**  
P, St. Louis



Radomski said Ron Villone told him to send Anavar and Deca-Durabolin to Franklin, and he did. In 2005, Franklin was suspended for a positive test for steroids.

**ERIC GAGNE**  
P, Milwaukee



Radomski said he mailed two kits of HGH to Gagne, each consisting of two kits of HGH. One was sent to Gagne's home in Florida; the other was sent to Dodger Stadium.

**JUAN GONZALEZ**  
OF, not in majors



In 2001, Canadian border officials found steroids and syringes in a bag but could never determine whether the bag belonged to Gonzalez, his trainer or another member of his entourage.

**JASON GRIMSLEY**  
P, not in majors



In 2006, Grimsley was suspended 50 games after he reportedly admitted that he had used HGH. Radomski produced 14 total checks written by Grimsley to Radomski.

**JERRY HAIRSTON**  
2B, Texas



Radomski said he sold HGH to Hairston on two or three occasions during 2003 and 2004.

**MATT HERGES**  
P, Colorado



Radomski said that he made two or three sales of HGH to Herges from 2004 to 2005. A check from Herges to Radomski is included in the report.

**PHIL HIATT**  
3B, not in majors



Radomski said he sold HGH and Deca-Durabolin on two or three occasions from 2001 to 2004.

**GLENALLEN HILL**  
OF, not in majors



Radomski said Hill purchased two kits of HGH in 2001. In an interview with Mitchell, Hill said he purchased Sustanon from Radomski but did not use it.

**TODD HUNDLEY**  
C, not in majors



Radomski said he sold Deca-Durabolin and testosterone on "three or four occasions" in 1996 to Hundley, the year he hit 41 homers; Hundley referred Lo Duca to Radomski.

**RYAN JORGENSEN**  
C, free agent



Suspended for 50 games in 2007 based on non-analytic evidence that he violated baseball's drug policy.

**WALLY JOYNER**  
1B, not in majors



Told Mitchell's investigators that he took steroids three times in 1998 before deciding it was a mistake and throwing away the pills.

**MIKE JUDD**  
OF, not in majors



Todd Seyler said he saw Judd inject himself with either Winstrol or Deca-Durabolin in July 1999 as part of a six-week steroid cycle.

**DAVID JUSTICE**  
OF, retired



Bought two or three kits of HGH after the 2000 World Series, according to Radomski. Yankees assistant strength coach Brian McNamee said Justice told him this was true.

**CHUCK KNOBLAUCH**  
IF, retired



McNamee said he acquired HGH from Radomski in 2001 and injected Knoblauch with HGH at least seven times. He said Knoblauch also acquired HGH from other sources.

**TIM LAKER**  
C, not in majors



Admitted using steroids starting before the 1995 season and to buying Deca-Durabolin and testosterone from Radomski in four transactions from 1995 to 1999.

**MIKE LANSING**  
IF, not in majors



Radomski said he had four or five transactions with Lansing for testosterone and HGH and produced two money orders from Lansing dated Feb. 5, 2002.

**PAUL LO DUCA**  
C, Washington



Radomski estimated that he had six transactions with Lo Duca. The report includes three checks written to Radomski by Lo Duca. Lo Duca then referred four other players.

**NOOK LOGAN**  
OF, free agent



Radomski said he sold Logan one kit of HGH in late 2005.

**CODY MCKAY**  
C, not in majors



Radomski said he twice sold steroids to McKay.

**MARK MCGWIRE**  
1B, retired



Of those who were interviewed by investigators, only Jose Canseco said he knew of McGwire using steroids. Canseco repeated allegations he first made in his book.

**JOSIAS MANZANILLO**  
P, not in majors



Radomski said he didn't sell him steroids but injected him with Deca-Durabolin in the Mets clubhouse in 1994, the only time he ever injected a player with steroids.

**KENT MERCKER**  
P, not in majors



Radomski said he sold HGH to Mercker once in 2002. A check from Mercker to Radomski and a shipping receipt are included in the report.

**BART MIADICH**  
P, not in majors



Radomski said Miadich frequently bought testosterone and Winstrol from 2002 to 2005, and he told Radomski he had bought HGH elsewhere.

**HAL MORRIS**  
IF, not in majors



Radomski said he sold Deca-Durabolin and testosterone to Morris in 1999. Through his lawyer he denied use, but not purchase or possession, of steroids, testosterone and/or HGH.

**DANIEL NAULTY**  
P, not in majors



Admitted to using steroids on and off for seven years beginning before the 1993 season and HGH for one year.

**DENNY NEAGLE**  
P, not in majors



Radomski said he sold Neagle HGH and anabolic steroids five or six times from 2000 to 2004.

**RAFAEL PALMEIRO**  
1B, not in majors



Tested positive for Stanozolol in May 2005 and was suspended 10 games. He said he never intentionally used the drug and said it may have come from tainted vitamin B12.

**JIM PARQUE**  
P, not in majors



Radomski said he made two sales of HGH to Parque.

**LUIS PEREZ**  
C, not in majors



While being interviewed involving his possession of marijuana, Perez told commissioner's office that he supplied steroids and other drugs to the Marlins as bullpen catcher.

**ANDY PETTITTE**  
P, N.Y. Yankees



Pettitte trains with Brian McNamee, who said he provided and injected Pettitte with HGH on two to four occasions when Pettitte was rehabilitating his elbow in 2002.

**ADAM PIATT**  
OF, not in majors



Former major leaguer admitted to using performance-enhancing drugs purchased from Radomski. He cooperated with the commission.

**TODD PRATT**  
C, not in majors



Purchased anabolic steroids from Radomski.

**STEPHEN RANDOLPH**  
P, Houston



Bought HGH once, according to Radomski.

**ADAM RIGGS**  
IF-OF, not in majors



In six to 10 transactions, bought HGH, clenbuterol and Winstrol, according to Radomski.

**ARMANDO RIOS**  
OF, not in majors



Victor Conte told federal agents he sold "the cream" and "the clear" to Rios. The San Francisco Chronicle reported Rios admitted using substances in grand jury testimony.

**BRIAN ROBERTS**  
2B, Baltimore



Former teammate Larry Bigbie says Roberts told him he injected himself "once or twice" with steroids.

**F.P. SANTANGELO**  
OF-IF, not in majors



Bought HGH, Deca-Durabolin and testosterone, according to Radomski.

**DAVID SEGUI**  
1B, not in majors



Purchased Deca-Durabolin, according to Radomski. Several unreported incidents involving Segui were also reported. Segui has publicly admitted using HGH.

**SAMMY SOSA**  
OF-DH, Texas



He is mentioned in the report only as a person who did not respond to Mitchell's request for answers to specific questions.

**MIKE STANTON**  
P, Cincinnati



Bought HGH twice, according to Radomski.

**RICKY STONE**  
P, Cincinnati



Injected himself with Deca-Durabolin while in the minors, according to former strength coach Todd Seyler.

**MIGUEL TEJADA**  
SS, Houston



Adam Piatt said he sold Tejada HGH and testosterone.

**DERRICK TURNBOW**  
P, Milwaukee



Was barred from international play for positive tests in 2003 but not from the majors because substances he took were not banned.

**MO VAUGHN**  
1B, not in majors



Radomski said he sold Vaughn HGH in 2001.

**RON VILLONE**  
P, N.Y. Yankees



Bought HGH three times, according to Radomski.

**FERNANDO VIÑA**  
2B, not in majors



Bought HGH and anabolic steroids, according to Radomski.

**RONDELL WHITE**  
OF, Minnesota



In "six to ten" transactions, bought HGH and Deca-Durabolin, according to Radomski.

**JEFF WILLIAMS**  
P, not in majors



Bought Anavar and Dianabol, according to Radomski.

**TODD WILLIAMS**  
P, Baltimore



Bought Winstrol once, according to Radomski.

**KEVIN YOUNG**  
1B, not in majors



Purchased HGH from Radomski.

**GREGG ZAUN**  
C, Toronto



An unnamed player ordered steroids for Zaun, who sent a check as payment, according to Radomski.

#### OTHERS: MEDIA REPORTS OF INTERNET PURCHASES

These 14 players were cited under "Alleged Internet Purchases of Performance Enhancing Substances By Players in Major League Baseball." The players were named in media reports; those still active in the majors were investigated by the commissioner's office. According to the report, "Players agreed to the interviews [with the commissioner's office] on the condition that the information they provided would not be shared with me." The players are OF Rick Ankiel, 3B David Bell, P Paul Byrd, DH Jose Canseco, OF Jay Gibbons, 3B Troy Glaus, RF Jose Guillen, P Darren Holmes, CF Gary Matthews Jr., P John Rocker, P Scott Schoeneweis, P Ismael Valdez, 3B Matt Williams, P Steve Woodard.

#### OTHERS: BALCO INVESTIGATION
